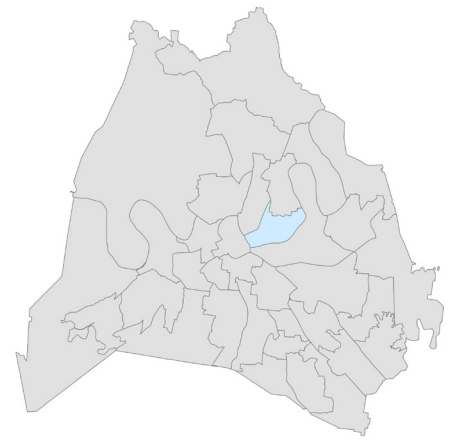
 Proposal C boundaries

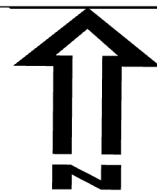

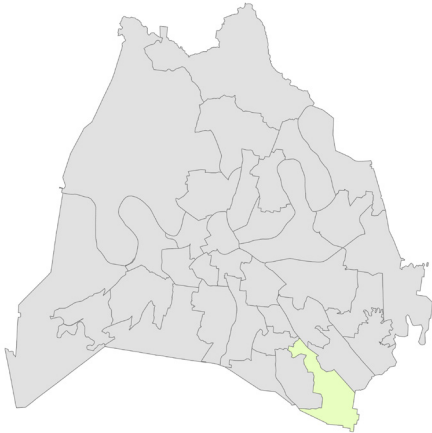
