



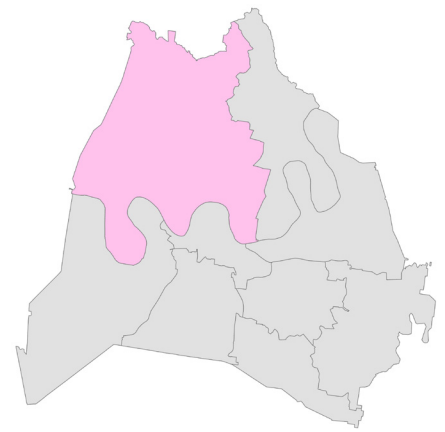
# SCHOOL BOARD RECOMMENDED PLAN

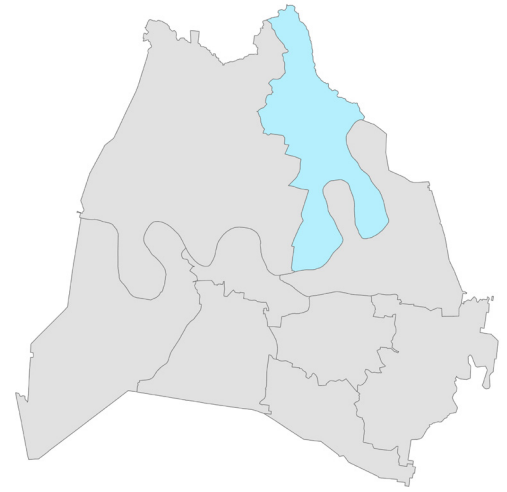

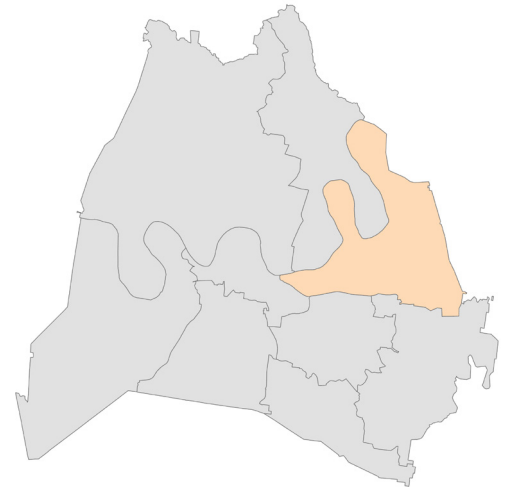

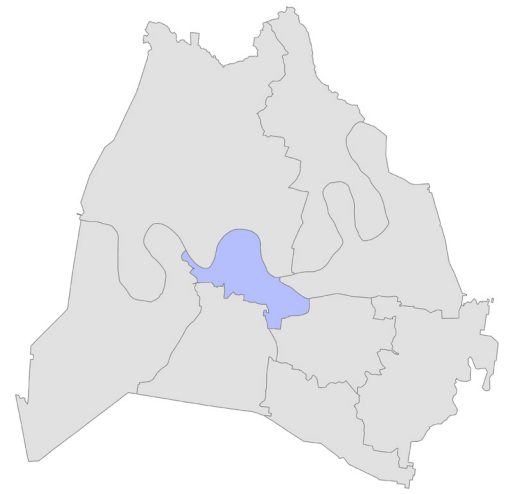

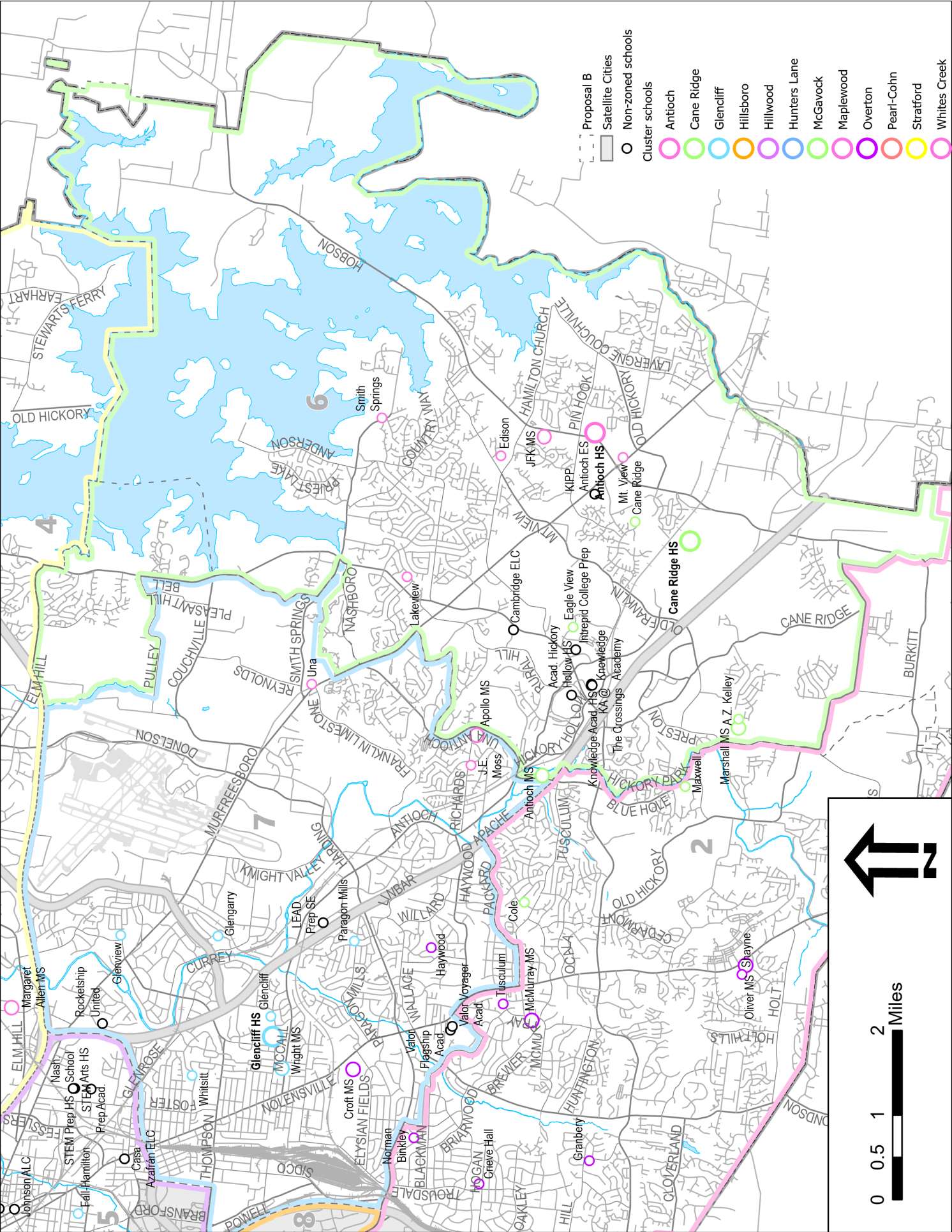

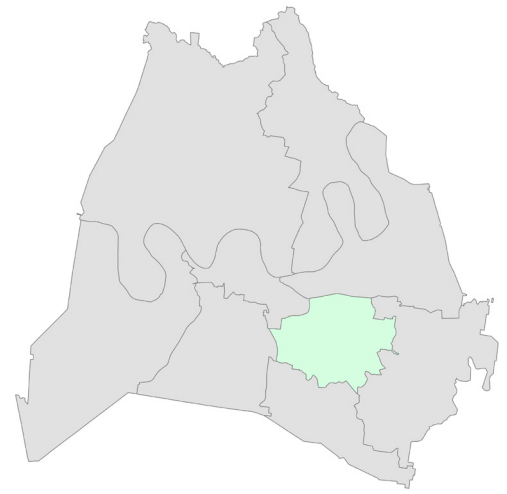
